Minutes of the Ordinary Meeting on Tuesday 1st October 2024

- **1.** Receive Apologies for Absence: Cllr Andrew Pike, Mrs M Holland, Mr J Turley and Ms J Watts
- 2. Declarations of Interest relating to this meeting: None
- 3. Public Involvement Session: No members of the public were in attendance.
- **4. Minutes:** To approve as a correct record and sign the minutes of the Parish Council meeting held on 3rd September 2024.
 - **RESOLVED:** to approve as a correct record and the chair signed the minutes.
- 5. Reports from Members
 - 5.1. Shropshire Council Cllr Motley reported that Shropshire Council is among a number of authorities that are experiencing financial difficulties. They have received nothing from the government on how they plan to deal with councils which are struggling. There is concern that the plans to build more houses may affect rural areas, particularly in areas where the infrastructure is already limited. Shropshire Council has responded to the new National Planning Policy Framework consultation. There has been a delay in the stickers for green bins being distributed continue to put green bins out as the refuse collectors know who has paid the fee. The new government wants more devolution. Shropshire Council is in discussions with Herefordshire, Worcestershire, Warwickshire and Staffordshire. Cllr Motley reported that she will not stand at the next election. Councillors were very saddened to hear this news as Cllr Motley has been an excellent councillor, acting on behalf of the Corvedale over many years.
 - 5.2. Village Hall Committee— Cllr Mear reported that the Bluebells event had been very successful. There is the Tractor Run on the 13th October, with proceeds going to the MS Society and Culmington Village Hall renovations and the Corvedale Choir will hold a Christmas concert at the Hall. The Clerk reported that an application to change the entry on the Land Registry for the Village Hall had been made.

- 7. Consider Use of the Neighbourhood Fund to Extend the Speed Limit to Clay Lane: The council has not received a response from the Place Plan team despite two emails. Cllr Motley suggested contacting Mr Newton, Traffic Engineer for Shropshire Council.
- 8. Consider a Response to Shropshire Council's Local Council Survey:
 RESOLVED: to respond that the council is willing to enter discussions with Shropshire
 Council but it does not have funding to support services presently funded by Shropshire
 Council. It does support the Environmental Maintenance Grant being fully reinstated
 next year and to have greater freedom about how the grant can be used within the
 parish.
